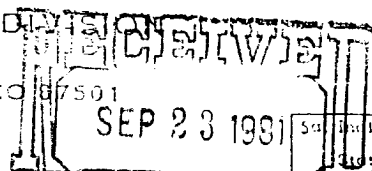

On 8-31-81 Aztec Drilling (Rig #50) spudded a 12-1/4" hole at 11:30 a.m. Drilled to a TD of 725' and ran 8-5/8" casing set at 721'. Cemented with 500 SX Class H cement. Plugged down 1:00 a.m. 9-3-81. Circulated 175 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 3480' and ran 5-1/2" casing set at 3478'. Cemented with 1000 SX Class H cement. Plugged down 12:15 a.m. 9-18-81. Circulated 200 SX. Currently waiting on completion unit.
