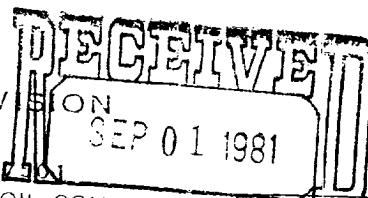

On 8-18-81 Aztec Drilling (Rig #50) spudded a 12-1/4" hole at 5:30 p.m. Drilled to a TD of 710' and ran 8-5/8" casing set at 701'. Cemented with 500 SX Class H cement. Plugged down 9:00 p.m. 8-20-81. Circulated 75 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 3825' and ran 5-1/2" casing set at 3824'. Cemented with 1000 SX Class H cement. Plugged down 1:30 a.m. 8-30-81. Circulated 150 SX. Currently waiting on completion unit.
