MISW 4-23-85 and killed well w/ 35 bbl 2% KCL FW, Rel pkr and Port w/ tbg and pkr. RIH w/ pkr and 3 1/2" tbg. Set pkr at 2050' and tested to 1000 psi - OK. Ran GR CCL log. Tagged PBTD at 2471 and pulled up WL and tools. Fraced down tbg w/ 260 bbl gelled 2% KCL, 79 tons CO₂ and 50,000# 8/16 SN. Flushed w/ 21 bbl CO₂. Shut-in for 1 hr and attempted to flow well back. Well had heavy concentration of SN so shut well in overnight. Flowed well and killed w/ 15 bbl 2% KCL FW, Rel pkr and POH. RIH w/ SN pump and CO SN from 2359 - 2473'. RIH w/ 1 jt 3 1/2" FG tbg, SN, and 3 1/2" tbg. Tbg LA 2069'.
