Plugged down at 10:30 am on 9-6-83. Tested casing to 800 psi for 30 min, and OK. Logged and ran 7" casing and set at 2652'. Cemented with 800 sacks class H and additives. Circulated 332 sacks. Plugged down at 3:30 am on 9-9-83. Rig released at 6:00 am on 9-9-83. Currently waiting on completion unit.
