Moved in wire line unit 5-29-85 and ran sinker bars. Tagged plugged back TD at 2,595'. Pull sinker bars out of hole and pressure tested casing and packer to 1000 psi - ok. Killed tubing with 25 BW 270 KCL and installed treating valve. Stimulated with 22 tons CO₂ and 257 ball sealers. Blew well down for 1 hour. Killed tubing with 25 BW 270 KCL. Installed production valve and turned thru separator for flow testing thru gathering system. PAWD: 1303 MCFD.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
