To reduce water production as follows: M.S.U. POH w/ tubing and packer. Set Cement retainer at 2420'. Cement squeeze w/ 150 sk Class H Cement. WOC 24 hours. Drill out Cement and retainer to 2800'. Pressure test squeeze to 1000 psi. RIH w/ 5" Tann Guns and perforate 2536-58', 2570-74', 2576-78', 2584-90' w/ 4JSF Swab dry and drop bar to perforate Tubb interval. Rerun production equipment and return well to production.
