On 10-19-83 Aztec Drilling Co. (Rig #56) spudded a 12-1/4" hole at 6:00 pm. Drilled to 723' and set 9-5/8" casing. Cemented with 390 sacks class H and additives. Circulated 210 sacks and plugged down at 12:15 pm. on 10-20-83. Tested casing at 600 psi for 30 min and OK. Logged and ran 7" casing set at 2800'. Cemented with 800 sacks class H and additives. Circulated 220 sacks and plugged down at 5:15 pm. on 10-25-83. Rig released on 10-25-83 at 7:00 pm. Currently waiting on completion unit.
