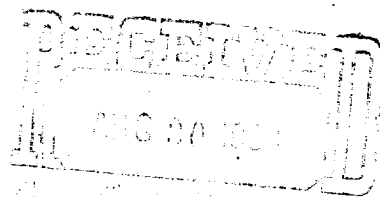

On August 13, 1984, Aztec Rig #56 spudded a 12 1/4" hole at 1:00pm drilling to 711 ft and set 9-5/8" casing. Cemented with 390 sacks class H cement with additives. Circulated 180 sacks cement to pit. Plugged down at 3:00am on 8-13-84. Wait on Cement 12 hours. Tagged cement at 662 ft and tested casing at 600 PSI for 30 minutes and ok. On August 17, 1984 ran 7" casing and set at 2930 ft. Cemented with 750 sacks Class H cement with additives and displaced 114 BBL 6% KCL. Maximum PSI to 2000#. Circulated 165 sacks to reserve pit. Plugged down at 7:30pm on 8-16-84. Set slips and cut off casing. Rig released August 16, 1984 at 9:30pm.
