MISU 8-2-85 and killed well with 20BW 2% KCl. Released packer and POH. Tagged PBTD at 2809'. RIH with workstring and packer. Set packer at 2192' and pressure tested casing and packer to 1,000 psi - ok. Frac Stimulated with 121BW 2% KCl and 35 tons CO₂. Flushed with 4 tons CO₂. Flowed back well for 2 hrs. Shut-in and killed well. Fractured with 307BW 2% KCl, 63 tons CO₂, and 74,364 # 8/16 Sand. Opened well to tank and flowed back well. Tagged PBTD at 2739'. POH with workstring. Re-ran production equipment. Tubing landed at 2314' and packer set at 2283'. MOSU 8-8-85 and flow tested 87.5 hrs. Returned well to production. Operations completed 9-17-85. PAWD: 1823 MCFD.
