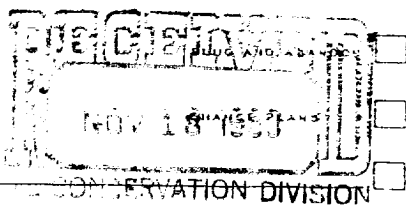

On 11-9-83 CO2-In-Action (Rig #16) spudded a 12-1/4" hole at 5:30 pm. Drilled to 715' and set 9-5/8" casing. Cemented with 890 sacks class H and additives. Circulated 195 sacks to pit and plugged down at 9:45 am on 11-10-83. Tested casing at 600 psi for 30 min and OK. Logged and ran 7" casing set at 2935'. Cemented with 950 sacks cement and additives. Circulated 89 sacks cement and plugged down at 9:45 pm on 11-14-83. Tested casing at 1500 psi for 30 min and OK. Rig released on 11-14-83 at 11:45 pm. Currently waiting on completion unit.
