On July 31, 1984 Aztec, Rig 56, spudded with a 12 1/4 hole at 8:00 p.m. On August 1, 1984 ran 9 5/8" casing and set at 720'. Cemented with 390 sacks class H cement with additives. Circulated 150 sacks cement to reserve pit. Plug held ok. Wait on cement for 12 hours. ON August 3, 1984 tested casing to 500 PSI for 30 minutes and ok. Ran 7" casing and set at 2798'. Cemented with 600 sacks Class H with additives. Circulated 117 sacks to reserve pit. Rig released on August 7, 1984 at 5:00 a.m.

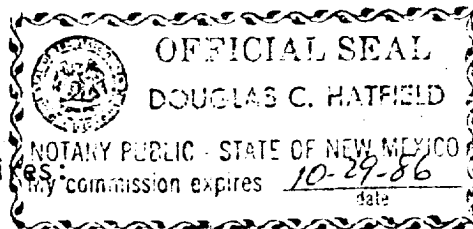
