On September 13, 1984, Aztec Rig 56 spudded a 12 1/4" hole at 5:00pm. On September 15 ran 9 5/8" casing set at 727 feet. Cemented with 390 sacks Class H cement with additives. Plugged down at 6:15 am on September 14, 1984. Tagged cement at 676 feet and tested casing at 600 PSI and ok. Wait on cement for 12 hours. On September 17 ran 7" casing and set at 2682 feet. Cemented with 750 sacks Class H Cement and circulated 228 sacks to pit. Plugged down at 3:30 pm on September 17, 1984. Rig released 6:30pm on September 17, 1984.
