Moved in service unit September 20, 1984. Perforated intervals 2061-2067, 2084-2090, 2093-2098, 2109-2128, 2131-2156, 2159-2164 with 2 JSPF. Ran and set packer 1910 feet stimulated well with 68 BBLs CO2 and drop 136 Ball Sealers and flush with 22 BBL CO2 with maximum pressure of 2200 PSI. Rig down and move out service unit September 22, 1984. Flow tested through a separator for 144 hours at an average rate of 1460 MCFD. Shut in well on September 29, 1984.
