Move in service unit September 10, 1984. Perforated intervals 2535-2539, 2551-2567, 2574-2623, 2630-2642 with 2 SPF. Ran and set packer at 2377 ft. pressure test packer with 700 psi. Stimulate well with 96 BBL CO2 and drop 4 ball sealers per bbl and flush with 22 BBL CO2 with a maximum of 2850 PSI. Rig down and move out service unit 9-17-84. Flow tested through a separator for 143 hours at an average rate of 2650 MCFD. Shut in well on September 24, 1984.
