On August 15, 1984, C02 in Action (Rig 16) spudded a 12 1/4" hole at 5:30p.m. Drilled to 721 ft and set 9-5/8 casing. Cemented with 390 sacks class H with additives, plugged down at 10:30 am on 8-16-84 and circulated 58 sacks to pit. Wait on cement for 12 hours, tested casing to 800 PSI and ok. On August 20 ran 7" casing and set at 2801, cemented 900 sacks class H cement with additives and displaced 115 barrels 6% KCL. Plugged down at 9:31 pm. Tested casing with 1150 PSI and circulated 116 sacks cement and nipple down blow out preventor and set slips. Cut off casing. Rig released 11:30pm August 20, 1984.
