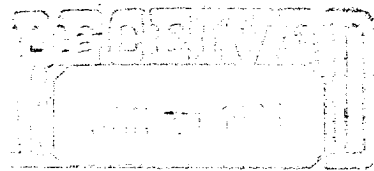

Moved in service unit 12-6-84. On 12-7-84 perforated intervals from 2238'-2486' W/2 JSPF. Packer set at 2095'. Acidized well with 75 BBL 2% KCL acid with additives. Stimulated well with 34 BBL liquid CO2 for cool down and 112 BBL liquid CO2 X 672 Ball sealers. Flow tested through a separator for 144 hours at an average rate of 3348 MCFD.
