Shut-in for 2 hrs. Flow'd to tank for shrs. POH and re-ran production equipment. Tubing landed 2396' and set packer at 2365'. MISU 12-19-85 and flow tested 195.5 hrs. Retained well to production. Operations completed 4-23-86.
