On 10-9-84 Aztec Rig #56 spudded a 12 1/4" hole and drilled to a total depth of 400'. Ran and set 9 5/8" casing at a depth of 726'. Cement with 390 sacks Class H cement with additives. Plugged down at 3:00pm 10-9-84. Circulated 101 sacks cement to reserve pit. On October 13, 1984 ran and set 7" casing at 2927'. Cemented with 1400 sacks Class H cement with additives. Plugged down at 7:45pm on 10-13-84. Did not circulate cement. Nipple down and set slips. Rig released 10-14-84 at 5:00am.
