On 12-6-84 ran and set 9-5/8 casing at 728 ft. Cemented with 390 sacks class h cement with additives. Plugged down at 9:00am on 12-6-84. Circulated 175 sacks to reserve pit. Wait on cement for 12 hours. Ran and set 7" casing at 2536 ft. Cemented with 550 sacks class H cement with additives. Circulated 200 sacks cement to reserve pit. Rig released 4:00 am on 12-14-84.
