Moved in service unit 4-15-85. Pull out of hole with tubing. Run in hole with cast iron bridge plug and set at 2229'. Displaced casing with 85 BBL's 10# brine with 25# gel per BBL. Spotted 25 sx class H cement on top of cast iron bridge plug. Spot 50 sx class H cement from 819'-624' across casing shoe. Wait on cement. Ran in with tubing and tagged cement at 630'. Cut off wellhead and moved out service unit 4-17-85. Turned over to rancher, no further report.

1. That he is District Manager of Amoco Production Company
(Title) (Operator)
whose address is P.O. Box 68, Hobbs, NM 88240.

2. That Amoco Production Company is the operator of a well drilled on land
(Operator)
belonging to the State of New Mexico and leased by Roderick F. Rock, whose address is
(Landowner)
Nara Visa, NM 88430, said well being drilled to test for hydrocarbons
and/or carbon dioxide gas and described as the BDCDGU Well No. 1836 161F,
being located 1980 feet from the west line and 1980 feet from the north
line of Section 16, Township 18 N, Range 36 E NMPM,
Union County, New Mexico.

3. That said well was drilled to a total depth of 2907 feet, and that
casing has been set and cemented as follows:

Surface casing - 9-5/8" set at 722 ft and cement circulated to surface
Production casing - 7" 20# set at 2907 ft and cemented and tied back to surface
casing at 665 ft.

4. That operator and landowner have made an agreement whereby operator (is)
(is not) to back fill pits, level location, and clear it of all junk. The agree-
ment further provides that operator is to plug said well back to a plugged-back
total depth of 630 feet and transfer well to landowner for his use as a water-
well. Operator will leave casing in the well as follows:
