Moved in and rigged service unit 12-19-84. On 12-21-84 perforated intervals 2250-2260, 2270-2280, 2290-2300 with 2 JSPF. Packer set at 2214'. Pressure test pack 1000 PSI and OK. On 12-22-84 ran swab unit and IFL 2150 ft from surface. Recovered .4 BNW. Stimulated well with 1000 gallons 7 1/2% HCL with additives and drop 6 balls per bbl and air. Rigged down and moved out service unit 12-29-84.
