Circulated 48 sacks cement to reserve pit. Plugged down at 4:15pm on 11-22-84. Wait on cement for 12 hours. On 11-26-84 ran and set 7" casing at 2910. Cemented with 750 sacks Class H cement with additives. Plugged down at 5:30 pm on 11-26-84. Rig released 8:30pm on 11-26-84.
