MIRUSU, kill well with fresh water, NUBOP, release packer, lay down production tubing and packer, run cast iron bridge plug with wireline, set CIBP at 2581 feet, SDON.

6/21/00

Run workstring, tag CIBP at 2581 feet, displace casing with corrosion inhibited fluid, pressure test casing to 500 psi, cap CIBP with 10 sacks of class C cement from 2581' - 2523', pull workstring to 2203 feet, spot 20 sacks of cement from 2203' - 2087', pull workstring to 30 feet, fill casing with cement, NDBOP, RDMOSU, cut off wellhead, install PXA marker, cut off well anchors and clean location.
