Frac down workstring x 162 bbl 2% KCL fresh water x 40 lb HEC gel x 45 tons CO₂ x 37,100 lbs 8/16 sand x tag x R/A material x 10 bbl flush. Max treating psi 4385 at 15.75 BPM. Shut in for 2 hours, open well to tank on 48/64" choke, rec. 40 BLW in 3 hours, SION. On 1-17-87, TPC 500 psi x CPC 0 psi. x bled to 50 psi in 15 min, TPC 50 psi for 2 hours on 48/64" choke. Tag sand at 2890'. Pull 3 1/2" workstring x pkr. R production tbg x 8 5/8" x 2 7/8" pkr, PSA 2585. Load csg x 50 bbls x prs test pkr 500 psi, ok. On 1-28-87, TPC 425 psi, bled to 25 psi x TPF 25 psi for 4 hours on 2" choke x rec 40 BLW. RDMOSU 1-28-87. On 1-29-87 flow test 24 hours, rec 100 BLW x gas TSTM at 5 psi TPF. On 1-30-87, flow test 24 hours, rec 100 BLW x gas test at 3 psi TPF. Shut well in on 1-30-87. On 2-4-87, 96" SITP = 190 psi. Bled to 0 psi in 5 min. On 2-8-87, flow test 27 hrs TPF at 26 psi on 1/4" choke. On 2-9-87, flow test 1 hour, well died, TPF 0 psi on 1/4" choke. On 2-10-87, 24 hrs SITP = 0 psi.
