Propose to abandon Ellenburger and establish production from Subb formation as follows: Spot a 100' cement plug from 3150'-3050' using 50 sp Class H Neat Cement. Perforate 2646'-2662' w/4 JSPF. Stimulate w/ total of 12 tons liquid CO₂ (using ball sealers in 33.7 bbls. of the liquid CO₂) and flush w/ 4 tons liquid CO₂. Swab flow to evaluate.
