On 9/27/85 Cylec Rig #56 moved in and rigged up. Spud well 9-28-85 with a 12 1/4" bit and drilled to TD of 690'. On 9/29/85 set 9 5/8" 36 #, K-55 csg set at 690'. Cemented with 390 sxs class H w/add. Plugged down and circulated out 30 sxs. WOC 18hrs and tested csg to 1500 psi for 30 min, tests OK. Drilled an 8 3/4" hole to TD of 2637'. On 10-4-85 ran 7", 20 #, K-55, csg. Csg set at 2637' and cemented with 550 sxs class H w/add. Did not circulate, Ran temperature survey and TCMT was at 1435'. Rig released 10-4-85. No further report until MISH
