MI and RUSU 5-15-87 and kill well. Release packer and pull 3-1/2" tubing and packer. Run sinker bar and tag PBDT at 2452'. Run packer and tubing and set packer at 2023'. RD and MOSU 5-15-87. MI and RUSU 5-19-87. Frac with 37 bbls 40# HEC gelled 2% KCl fw, 10,000# 8/16 sand and 17 tons CO₂. Average injection rate 15 BPM and maximum pressure 1910 psi. POH. Run tubing and packer set at 2269 and return to production. RD and MOSU 5-21-87..
