Pressure tested casing for 30 mins-OK. Reduced bit to 8 3/4" and resumed drilling. Drilled to a T B of 2517'. Ran 7" 20# K-55 Casing and set at 2518'. Cemented with 6005X class H/cadd. Circulated 1005X to pit. Rig released 10:30 am 10-14-85. No further report until MCH.
