Martin No. 22 spud the subject well on 10-26-85 with a 12 1/4" bit. Drilled to a TD of 704'. On 10-28-85, ran 9 5/8" casing and set at 704'. Cemented with 425 SX class H cement. Circulated 60 SX to pit. WOC. Pressure tested casing 1000 psi for 30 mins - ok. Reduced bit to 8 3/4" and resumed drilling. Drilled to a TD of 2474'. On 10-31-85, ran 7" casing and set at 2474'. Cemented with 800 SX class H. Circulated 400 SX to pit. Rig released 10-31-85. No further report until MICU.
