Murfin No. 22 spud the subject well 10-31-85 with a 12 1/4" bit. Drilled to a TDO of 700'. On 11-1-85, ran 9 7/8" 32.3# H40 casing and set at 700'. Cemented with 425 SX class H with 2% CACK. Circulated 60 SX to pit and WOC. Pressure tested casing 1200 psi for 30 mins - OK. Reduced bit to 8 3/4" and resumed drilling. Drilled to a total depth of 2489'. On 11-4-85, ran 7" 20# K-55 casing and set at 2490'. Cemented with 800 SX Class H w/addits. Circulated 400 SX to pit. Rig released 10:30 am, 11-4-85. No further report until MICU.
