Sutton Rig No. 1 spud the subject well on 10-16-85 with a 12 1/4" bit. Drilled to a total depth of 704'. On 10-17-85, ran 9 5/8" 32.3# casing and set at 705'. Cemented with 390 SX Class H cement with 2% CACI. Circulated 106 SX to pit. WOC. Pressure tested casing to 1500 psi for 30 mins. -ok. Reduced bit to 8 3/4" and resumed drilling. On 10-19-85, ran 7" 20# casing and set at TD of 2351'. Cemented with 650 SX class H and additives. Circulated 149 SX to pit. Rig Released 2:00am., 10-20-85. No further report until MICU.
