AZTEC Rig No. 56 spud the subject well 11-25-85 with a 12 1/4 bit and drilled to a TD of 725'. On 11-26-85, ran 9 7/8" casing and set at 725'. Cemented w/ 3905X class H w/ 2% CaCl₂. Circulated 795X to pit. WOC. Pressure tested casing 1500 psi for 30 mins - ok. Reduced bit to 8 3/4" and drilled to a TD of 2669'. On 11-30-85, ran 7" casing and set at 2669'. Cemented casing w/ 6005X class H w/ additives. Circulated 2505X to pit. Rig released 4:00 pm, 11-30-85.
