AETEC Rig No. 56 spud the subject well 10-30-85 with a 12 1/4" bit. Drilled to a TD of 710'. On 10-31-85, ran 9 7/8" casing and set at 710'. Cemented with 390 SX class H cement. Circulated 206 SX to pit. WOC. Pressure tested casing to 1500 psi for 30 mins. - ok. Reduced bit to 8 3/4" and resumed drilling. Drilled to a TD of 2227'. On 11-3-85, ran 7" casing and set at 2223'. Cemented with 600 SX class H cement. Circulated 112 SX to pit. Rig released 4:30am 11-3-85. No further report until MICU.
