Aztec Rig No. 56 spud the subject well on 10-25-85 with a 12 1/4" bit. Drilled to a TD of 705'. Ran 9 7/8" casing and set at 705'. Cemented with 390 sx Class H cement with 2% CACI₂. Circulated 121 sx to pit. WOC. Pressure tested casing to 1500 psi for 30 mins - OK. Reduced bit to 8 3/4" and resumed drilling. Drilled to a TD of 2547'. On 10-29-85, ran 7" casing and set at 2547'. Cemented with 450 sx class H with additives. Did not circulate cement. Ran temperature survey, TCMT at 215'. Rig released 5:00 pm, 10-29-85. No further report until MICU.
