Aztec No.56 spudded the subject well on 10-20-85 with a 12 1/4" bit. Drilled to a total depth of 706'. On 10-21-85, ran 9 5/8" 32.3# casing and set at 705'. Cemented with 390SX Class H w/additives. Circulated 150SX to pit. WOC. Pressure tested casing to 1000 psi for 30 mins - ok. Reduced bit to 8 3/4" and resumed drilling. Drilled to a TD of 2597'. On 10-24-85, ran 7" 20# casing and set at 2594'. Cemented with 700 SX Class H cement with additives. Circulated 190SX. Rig released 2:00 pm, 10/24/85. No further report until MICU.
