Service Rig No. 6 spud the subject well 11-3-85 with a 12 1/4" bit and drilled to a TD of 700'. On 11-4-85, ran 9 7/8" 32.3# casing and set at 700'. Cemented with 390SX with additives. Circulated 1585X to pit. WOC. Pressure tested casing 1500 psi for 30 mins - ok. Reduced bit to 8 3/4" and resumed drilling to TD of 2402'. Ran 7" 20# casing and set at 2402'. Cemented with 700SX class H cement and circulated out 2175X to pit. Rig released 8:45 am, 11-10-85. No further report until MICU.
