Aztec Rig No. 56 spud the subject well 11-3-85 with a 12 1/4" bit. Drilled to a TD of 725' and ran 9 7/8" 32.3# casing and set at 725'. Cemented with 3905X class H cement and circulated 145 SX to pit. WOC. Pressure tested casing 1500 psi for 30 mins - ok. Reduced bit to 8 3/4" and resumed drilling to TD of 2395'. Ran 7" 20# casing and set at 2374'. Cemented with 5005X class H and circulated 145 SX to pit. Rig Released 4:00pm, 11-7-85. No further report until MICU.
