Service Rig No. 6 spud the subject well 11-23-85 with a 12 1/4" bit and drilled to a TD of 708'. On 11-24-85, ran 9 5/8" and set 704'. Cemented with 3905x class Hw/2% CaCl₂. Circulated 635x cement to pit. WOC. Pressure tested csg to 1,200 psi for 30 mins - ok. Reduced bit to 8 3/4" and drilled to a TD of 2,380'. Ran 7" and set at 2,380'. Cemented w/ 6505x class Hw/addits. Circulated 1945x to pit. Rig released 4:55 pm, 11-28-85. No further report until MICU.
