Move in rig up rotary tools. Spud @ 11:40. Drill 12-1/4" hole to 743'. Run 17 jt. 8-5/8" casing. Set @ 743'. Cement with 285 sacks Prem Plus 2% cc 1/4# Flocele. Circulate 100 sacks to pit. Wait on cement. Test 8-5/8" to 500 psi. Held ok. Drill 7-7/8" hole 743'-2255'. Run 55 jt. 5.5" 14# casing. Set at 2250'. Cement with 235 sacks Prem Plus. Circulate 100 sacks to pit. Bump plug @ 5:15 5-17-98. Rig down move out rotary tools. Wait on completion unit.
