Test 8-5/8" to 500 psi for 10 min. Held OK. Drill 7-7/8" hole to 2315'. Run 5.5 casing. Cement with 140 sacks Midcon Prem. Plus. Tail in with 75 sacks Midcon Prem. Plus. Trace of cement to pit. Shut in. Wait on service unit. MORT
