DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

This hole is down to 570 ft., and there is shale caving in and sometimes it sticks to the bit. We have 500 ft. of 8 inch casing to run in this hole to shut off this shale from falling on bit. (As reported January 4, 1952).

Supplementing the above, the 8 inch casing was landed but thereafter we hit water and could not find a hard seat to cement this casing. It was our intention to use the 8 inch string on further but we have decided to use a 6 1/2 inch string. We think we have found a hard seat for the 6 1/2 inch string and intend to have the Halliburton Co. cement same. Will keep you advised of future developments.

As soon as the 6 1/2 inch casing is at the well we will forward to you Miscellaneous Notice of intention to cement casing. We will also forward you a copy of Halliburton's Report or pink-slip receipt.
