The subject well has been drilled to a total depth of 5308' in Granite. No oil or gas was encountered in commercial quantities. Permission is requested to plug and abandon the well as follows: Set cement plugs 5200-5308, 5000-5100, 750-850, 550-650, surface to 25'. Recover approximately 800' of 9 5/8" casing. Restore location to original condition. Erect a 4" x 4' marker.

A subsequent report will be submitted upon completion of the above work.
