Plug was set at ²⁵⁸⁰~~2285~~ ft. (LN CI BP8). 6 holes from 2564 to 2565. 6 holes from 2400-01. 6 holes from 2392-93. 6 holes from 2378 -79. 12 holes 2344-48. These perforations were made from Lane-Wells Radioactive Log.

Some water was encountered, but this shows to be trapped water. Rig will be left over hole for clean-out purpose for at least 30 days.
