Set 8-5/8" OD 32# 58 thd. NSS C45 used casing at 952' as the intermediate string. Cemented entire string by circulating cement back to surface using 555 sz. bulk cement (cemented by Halliburton). Job completed 4:30AM 4/30/47- At noon 5/2/47- tested casing shut-off with 1000# pump pressure- held OK.
