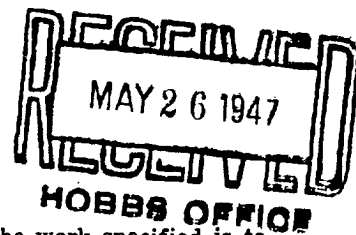

FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

After drilling to a TD-3564' and taking a drill stem test of lower zone, then plugging back from 3564' to 3380' with 110 sx. cement, then drill stem testing the zone from 3362' to 3380' which showed only salt water, we desire to plug and abandon this well by leaving rotary mud in it from the PB depth of 3380' to approximately the bottom of the 8-5/8" casing, then cement inside the 8-5/8" casing with approximately 75 sx of cement, test the cement plug, then filling the balance of the 8-5/8" casing with rotary mud, and steel cap the well to complete the plugging of it.
