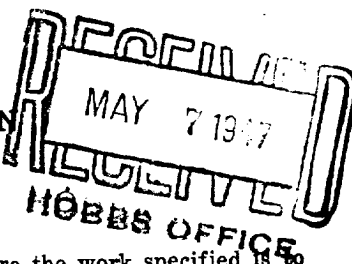

FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION
 After plugging back to 2611' (8" Csg set @ 2686') and knocking off the 5" casing at 1535' and pulling it, we tested the open hole below the 8-5/8" casing (8-5/8" Csg set at 1515') and found it making an estimated 15 bbls. of water per hour with no show of oil or gas. We now propose to plug the well by leaving the 5" casing in the hole up to 1535', then cementing from 1535' back up into the 8-5/8" casing to around 1340' (former plug backs left solid cement from 3100' to 2611'), test the cement plug, and then fill to surface with heavy rotary mud, and steel cap the well to complete the plugging of it.
