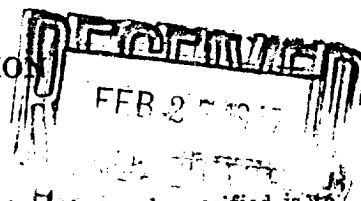

FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

After plugging back to a total depth of 2735' and testing the formation from the bottom of the 5 $\frac{1}{2}$ " casing @ 2686' to the plug back depth of 2735' and finding only salt water with no show oil or gas, we wish to cement back up into the 5 $\frac{1}{2}$ " casing to approximately 2600', then knock off the 5 $\frac{1}{2}$ " casing at around 2200', pull the 5 $\frac{1}{2}$ " casing, then test the open hole by bailing- from the bottom of the 8-5/8" casing @ 1515' to the top of the 5 $\frac{1}{2}$ " casing left in hole at around 2200'.
