FULL DETAILS OF PROPOSED PLAN OF WORK

Approx. 4400' of 7" 30# casing is cemented in this well. Intend to set a 40 ft. cement plug above 4400' and wherever 7" casing is parted and pulled. Place a ten sack cement plug at 1350', place a ten sack cement plug at 1100' place a 10 sack cement etc., at 450', and a ten sack cement plug at surface in 11 3/4" cemented casing. Place a ten sack cement plug at 190' (Base of 11 3/4" surface pipe.) Latter plug to hold regulation O. C. C. Metal Marker Pipe. All intervals between above plugs will be filled with heavy mud during cementing process.
