9 inch is now landed at 500 Ft. A cement plug from 575 Ft. to 600 Ft. We propose to set 7 inch liner from bottom plug up 100 Ft. putting it about 25 Ft. in the 9 inch.

First electric logging by Halliburtons, then cementing this liner and gun perforating to be followed with 2000 gallons of acid. Surface water was encountered at 108 Ft. 315 Ft. of 10 inch was set but does not reach through the water strata pipe is hanging on edge, end back of pipe is well loaded with good mud which is drilled very much to get on down behind the 9 inch by pulling this whole string of pipe
