

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Cemented 5807' of 9-5/8" casing, set at 5820' with 2500 sacks 10% gel and 200 sacks neat bulk cement. Job complete 10:55 P. M. 3-10-53. Circulated out approximately 500 sacks.

Tested 9-5/8" casing at 4:00 P. M. 3-13-53 with 1500# for 30 minutes. No drop in pressure. Drilled plug at 4:00 P. M. 3-13-53 and made 3' of hole and tested formation with 1500# for 30 minutes. No drop in pressure.
